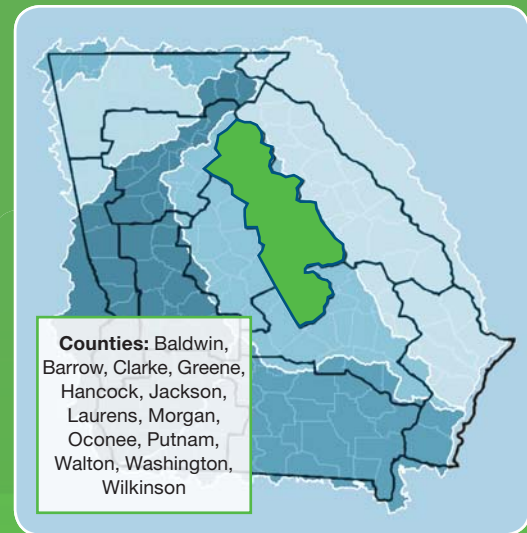


UPPER OCONEE REGION

BACKGROUND

The 2004 Comprehensive State-wide Water Management Planning Act authorized the development of the State Water Plan. The State Water Plan, which was adopted by the General Assembly in 2008, calls for:

- the preparation of regional water plans;
- the establishment of ten regional water planning councils to prepare the plans; and,
- the Georgia Environmental Protection Division (EPD) with providing technical assistance to the councils including contractor support, guidance, resource assessments and forecasts.

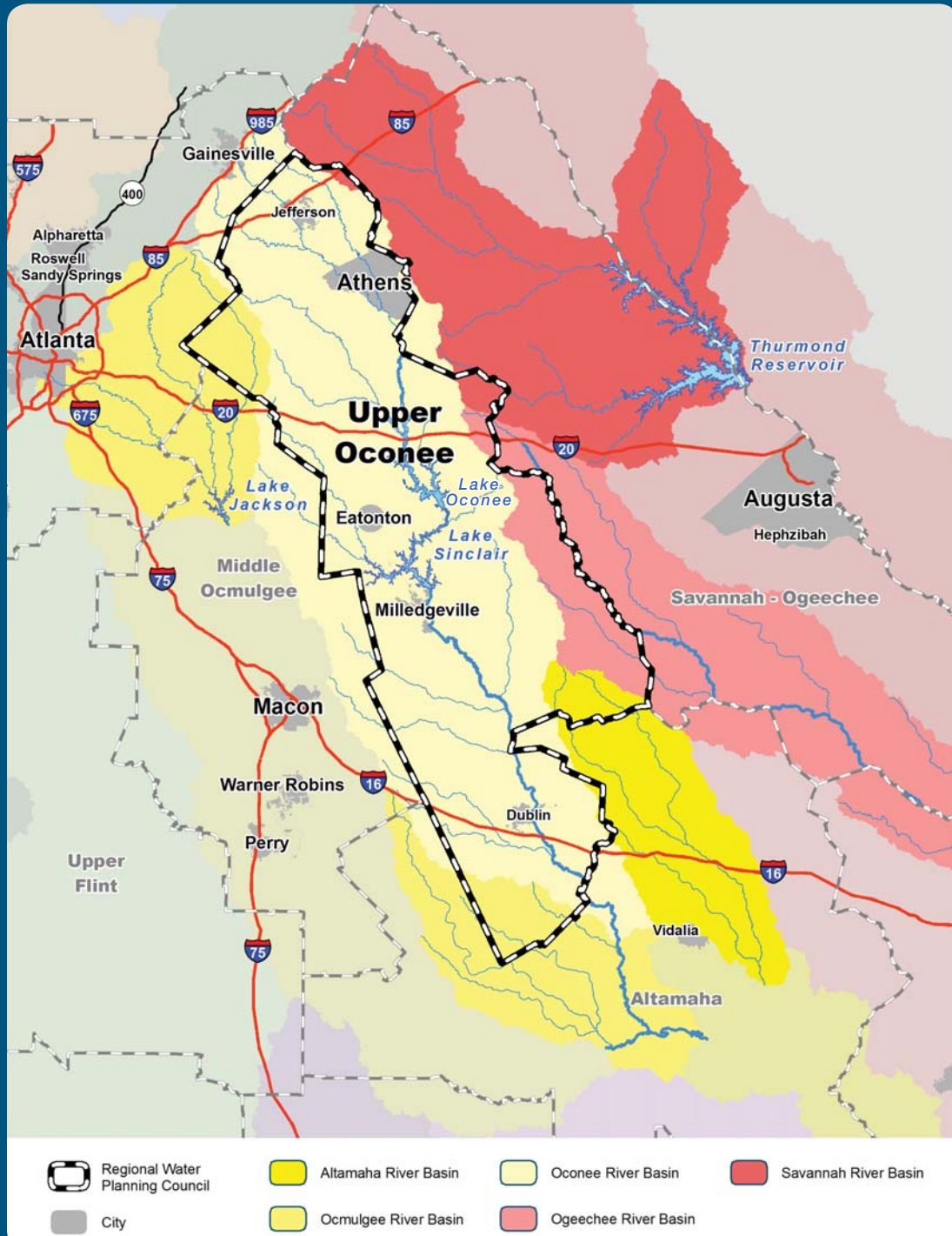

KEY WATER RESOURCE ISSUES BEING ADDRESSED BY THE COUNCIL

1. Efficient use of water by all sectors, recognizing the diverse characteristics of the Upper Oconee region
2. Future water supply storage in the upper basin (Jackson, Barrow, Oconee, and Walton Counties) where localized growth in demands is expected to exceed existing capacity
3. Future water supply demands in the central basin (Morgan, Putnam, and Greene Counties) and potential limitations placed on future surface water supplies in existing impoundments
4. Protecting the water quality of Lakes Oconee and Sinclair and the Oconee River by reducing nonpoint source nutrient loads
5. Future water supply yield of Coastal Plain aquifers
6. Assimilative capacity in the lower basin (Laurens, Washington, and Wilkinson Counties) due to zones of low dissolved oxygen
